## **ORDER**

A Revision Application F.No. 380/ 16/ B/ 2017- RA dated 13.06.2017 has been filed by the Additional Commissioner of Customs, NSCBI Airport, Kolkata (hereinafter referred to as the applicant) against the Commissioner (Appeals)'s Order No KOL/CUS(Airport)AA/359/2017 dated 06.04.2017 whereby the departmental appeal filed before him against the order of the Additional Commissioner of Customs is rejected as time barred.

- 2. The applicant has filed the Revision Application mainly on the ground that Commissioner of Customs(Appeals) has not gone through the merit of the case and has rejected the departmental appeal erroneously on the technical ground of time limitation only.
- 3. A Personal Hearing was offered in the case on 13.09.2018. But no one appeared for the applicant and no request for any other date of hearing was also received from which it is implied that the applicant is not interested in availing this hearing.
- 4. The Government has examined the matter and it is observed that the Commissioner (Appeals) has rejected the departmental appeal as time barred on the ground that no power to condone any delay is provided under Section 129 D of the Customs Act under which the appeal was filed by the department before him involving delay of 110 days. In the revision

application, the above finding of the Commissioner (Appeals) that he is unable to condone the delay of 110 days has not been countered by the applicant in any manner and it is merely avered that time limitation is only a technical ground. However, government is unable to accept the above flimsy argument as time limitation is a substantiate ground and cannot be condoned by any one in absence of any authority of law. Therefore, the government finds that the applicant has failed to make out any case for warranting any interference in the order of the Commissioner(Appeals).

5. Accordingly the Revision Application is rejected.
