## **ORDER**

A Revision Application No. 195/196/2018-R.A. dated 13.08.2018 has been filed by M/s P. C. Chandra Gems Pvt. Ltd., Kolkata (hereinafter referred to as the Applicants) against the Order-in-Appeal No. 82/Kol-I/2018 dated 28.03.2018 passed by Commissioner of CGST & Central Excise (Appeals), Kolkata, wherein the appeal filed by the Applicants against Order-in-Original No. 10/Joint Commissioner/Kol-I/C.Ex/2014 dated 08/11/2014 passed by the Joint Commissioner, Central Excise, Kolkata-I, has been rejected.

- 2. The brief facts leading to the present proceedings are that the Applicants were engaged in the manufacture of excisable goods, namely, articles of gold and silver. A Show Cause Notice was issued to the Applicants alleging that they had cleared gold bars without payment of central excise duty of Rs. 47,059/- and without observing the formalities envisaged under Central Excise Rules, 2002. The demand of the said duty was confirmed and a penalty of Rs. 47,059/- was imposed, vide the abovesaid Order-in-Original dated 08/11/2014. The appeal filed before the Commissioner (Appeals) was rejected, vide the impugned Order-in-Appeal dated 28.03.2018.
- 3. The instant revision application has been filed contesting the orders of the lower authorities on various counts.
- 4. Personal hearing was held on 10.11.2021, in virtual mode. Ms. Ruby Bhalotia, CA, appeared for the Applicants and submitted that the matter has been settled under SVLDRS. The requisite amount has been paid vide Challan No. (SVLDRS-4) L050320SV400911 dated 05.03.2020. Hence, the present RA has become infructuous. Sh. Saibal Gupta, Superintendent, appeared for the Respondent and submitted that since the matter has been settled under SVLDR Scheme, he has nothing further to add.

- 5. The Government has examined the matter. The matter in this case pertains to non-payment of central excise duty on gold bars and its demand under Section 11 A of the Central Excise Act, 1944. A case of this nature is not covered under the first proviso to sub-section (1) of Section 35 B of the Central Excise Act, 1944. The Government, therefore, holds that the instant revision application is not maintainable under Section 35EE.
- 6. Further, it has been averred by the Applicant that the matter has been settled under Sabka Vishwas (Legacy Dispute Resolution) Scheme and the requisite amount has been paid vide Challan No. (SVLDRS-4) L050320SV400911 dated 05.03.2020. This has been verified by the Respondent department vide latter C. No. V(30)2/22/TBL/CE/Kol-I/2015/16886 dated 01.10.2021. Hence, the present RA has also become infructuous.

7. The revision application is dismissed as non-maintainable and for being infructuous.
