<u>ORDER</u>

Revision Application No. 380/06/B/SZ/2018-RA dated 15.01.2018, has been filed by the Pr. Commissioner of Customs, Chennai-I, Chennai (hereinafter referred to as the Applicant department) against the Order-in-Appeal AIRPORT. C.Cus.I. NO. 179/2017 dated 28.09.2017 passed by the Commissioner of Customs (Appeals-I), Chennai. The Commissioner (Appeals) has modified the order of the Joint Commissioner of Customs, Airport, Chennai, bearing no. 74/2017-18-AIRPORT dated 21.07.2017, by reducing redemption fine from Rs. 4,50,000/- to Rs. 2,40,000/- and setting aside the penalty of Rs. 1,00,000/- imposed on the Sh. Manoram Chitanya Das, Chennai (hereinafter referred to as the 'Respondent') under Section 114AA of the Customs Act, 1962. Vide the aforementioned Order-in-Original, 02 semi-finished gold chains, 01 crude gold kada and 01 crude gold ring, totally weighing 325 gms and collectively valued at Rs. 9,64,275/-recovered from the Respondent, were confiscated under Sections 111(d) & 111(l) but allowed to be redeemed for re-export on payment of redemption fine of Rs. 4,50,000/-. Besides penalties of Rs. 1,00,000/- were imposed on the Respondent, each under Section 112(a) and 114AA of the Act, ibid.

- 2. The revision application has been filed, mainly, on the grounds that the gold items were attempted to have been smuggled by the Respondent herein without declaring the same under Section 77 of the Customs Act, 1962; and that penalty under Section 114AA of the Customs Act, 1962 is imposable on the Respondent as a false declaration had been made by him by suppressing the possession of gold when questioned in the presence of witnesses.
- 3. Personal hearing in the matter was fixed on 01.02.2023. In the hearing held, in virtual mode, on 01.02.2023, Sh. Anburaju, AC appeared for the Applicant department and reiterated the contents of RA. Sh. Manoram Chitanya Das, Respondent appeared and stated that his RA against the same OIA has been decided earlier by AS(RA), Mumbai wherein RF is reduced to Rs. 1,20,000/- and PP under Section 112 to Rs. 50,000/-. Sh.

Anburaju, AC confirmed that the goods have been released to the Respondent herein based on AS(RA) Order and RF/PP was paid vide Challan dated 09.10.2020.

4. The Government has carefully examined the matter. It is observed that the Respondent herein had filed Revision Application, bearing no. 373/19/B/17-RA against the Order-in-Appeal impugned herein and the said RA has already been decided by the Revisionary Authority at Mumbai in the year 2020, vide GOI Order bearing no. 81/2020-Cus(SZ)/ASRA/Mumbai dated 22.06.2020. In these circumstances, the instant revision application has been rendered infructuous. The revision application is disposed of, accordingly, without traversing the merits of the case.
