## <u>ORDER</u>

A Revision Application No. 373/414/B/2019-RA dated 14.10.2019 has been filed in the name of Sh. Y. Sadik Basha, Ramnathpuram (hereinafter referred to as the Applicant), against the Order-in-Appeal 63/2019-TRY (CUS) dated 11.07.2019, passed by the Commissioner of Customs & Central Excise (Appeals), Tiruchirapalli. The Commissioner (Appeals) has, vide impugned Order-in-Appeal, rejected the appeal filed by the Applicant herein against Order-in-Original No. 04/2018 dated 12.12.2018 read with Corrigendum dated 27.01.2019, passed by the Assistant Commissioner of Customs, Airport, Madurai.

2. The Applicant herein was intercepted at Madurai Airport upon his arrival, on 17.02.2018, from Colombo and was found to be carrying goods as per details below:

The original authority, after following the principles of natural justice, ordered for absolute confiscation of 4,800 nos. of cigarettes under Section 111 (d), (l) & (m) of the Customs Act, 1962. The electronic items, totally valued at Rs. 7,34,000/-, were also held liable to confiscation but were allowed to be redeemed on payment of redemption fine of Rs. 2,20,000/-. A penalty of Rs. 83,000/- was also imposed on the Applicant herein under Section 112 (a) & (b) of the Customs Act, 1962. The appeal filed by the Applicant herein has been rejected by the Commissioner (Appeals), as time barred.

3. The revision application has been filed on various grounds including on merits. However, the application is unsigned. This position was brought to the notice of the

Applicant, vide letters dated 12.01.2023, 20.01.2023 and 15.02.2023, for rectification. The requisite court fee stamps have also not been furnished despite advice.

- 4. Personal hearing in the matter was fixed on 20.01.2023, 08.02.2023 and 01.03.2023. No one appeared for either side on any of the dates fixed for hearing nor any request for adjournment has been received.
- 5. The Government has carefully examined the matter. Since the revision application is unsigned, it cannot be entertained. The application is, accordingly, rejected in limine.
