## **CIRCULAR**

Subject: <u>Cleanliness in the Department of Revenue - Celebration of Swachhata</u>

It is therefore, requested that all the sections must digitize all the records and weed-out the old records, positively by 15<sup>th</sup> September, 2018, so that proper cleanliness is maintained in all offices/sections and a clean and hygienic ambience is created in all offices/sections of the Department before beginning of the 'Swachhata Pakhwada'. Heads of the Divisions must personally monitor digitization/weeding out of records and cleanliness of the sections on regular basis. The officers/Staff of the Department may take active part in the cleanliness drive by undertaking fresh initiatives and applying innovative ideas so that the 'Swachhata Pakhwada' being celebrated in this Department becomes a splendid success.
